- (e) The Managing Trustee shall be the Drawing and disbursing officer.
- (f) The Managing Trustee will initiate action for conducting and periodically updating socio-economic profiles and survey and for identifying areas locations and target groups for planning and formulation of the work plan.

- (o) The Managing Trustee shall be the custodian of all documents and assets of the Board of Trustees.

16. **Financial year**

Financial Year shall be from 1st April to 30th March of next calendar year.

17. **Legal Status**

The Managing Trustee may sue / may be sued on behalf of the Trust for moveable or immovable properties.

18. **Termination of the Trust**

- In case of winding up or dissolutions of the trust their remains after the satisfaction of the debts and liabilities, any profit whatsoever, the same shall not be distributed among the members of the trust, that shall be given or transfer to any society or institution having similar objects of the trust to be determined by members of the trust.

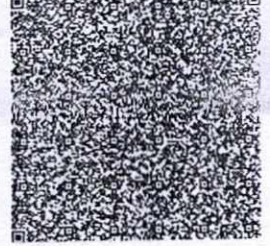
